INDEX DESCRIPTION


CECE Socially Responsible Investment (CECE SRI) is a free float market-cap weighted price index made up of the leading sustainability-driven companies traded on stock exchanges in Central, Eastern and South-Eastern Europe. Eligible companies must pass sustainability criteria based on research by Mag. Friesenbichler Unternehmensberatung. The index is calculated in EUR and disseminated in real time.

CECE SRI is designed as a tradable index to be used as an underlying instrument for structured products and for standardized derivatives (futures & options).


