

# ATX TD DSTB - ATX Top Dividend Distributing

## INDEX DESCRIPTION

ATX Top Dividend Distributing (ATX TD DSTB) is a variation of ATX TD. The distributing concept introduces a theoretical cash component which reproduces net dividend payments. A resetting of this cash component to zero twice a year reflects the distribution of the accumulated dividends (plus accrual of interest using the Euro Short-Term Rate - ESTR). The index is calculated in EUR and disseminated in real time.

ATX TD DSTB is designed as a tradable index to be used as an underlying instrument for structured products and for standardized derivatives (futures & options).

Constituent weights are capped on a quarterly basis to ensure compliance with UCITS standards for portfolio diversification.


