INDEX DESCRIPTION

CECE Top Dividend Net Total Return (CECE TD NTR) is a free float weighted total return index made up of the 15 stocks of the CECE with the highest dividend yield. Due to the consideration of net dividend payments the index reflects the net total return of the underlying portfolio. The index is calculated in EUR and USD and disseminated in real time.

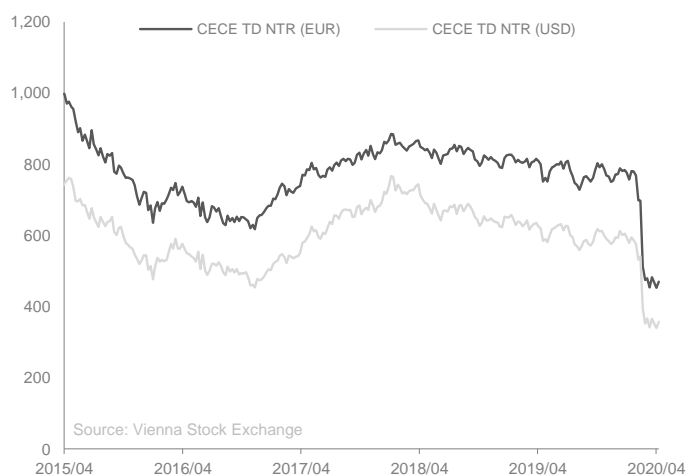
CECE TD NTR is designed as a tradable index to be used as an underlying instrument for structured products and for standardized derivatives (futures & options).

Constituent weights are capped on a quarterly basis to ensure compliance with UCITS standards for portfolio diversification.

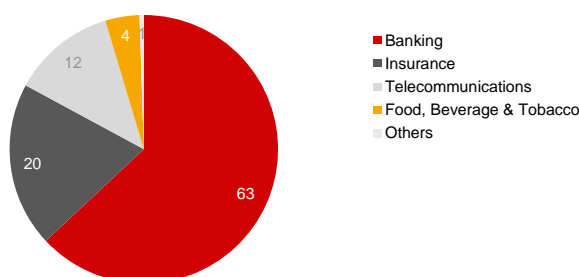
