REPLOID Group AG ("REPLOID") has signed a non-binding letter of intent ("LoI") with the 11er Group regarding potential future cooperation in the field of potato peel recycling using insect larvae. Based on the key points set out in the LoI, REPLOID and 11er will examine the potential for implementing a joint insect farming facility in Vorarlberg for the utilization of food waste, in particular potato peelings, and for the regional distribution of insect raw materials, with a focus on a special organic soil improver (fertilizer) for regional agriculture, particularly potato cultivation

The long-established 11er Group has its core competence in potato processing and specializes in potato specialties such as French fries, croquettes, rösti, rösti pockets, and related products. 11er supplies both the food retail trade and the catering industry and is internationally recognized as an innovative player in the potato processing sector of the food industry.
