

CEE & CIS Emergency Committee Decision effective as of 17 May 2022

On April 16, 2022, Russia adopted Federal Law No. 114-FZ which prohibits Russian issuers from having their shares traded outside Russia via depositary receipts (DRs) and requires issuers with existing programs to take measures to delist and terminate their DR programs.

DR holders are entitled to obtain the shares underlying their DRs. Companies already listed abroad will have to delist unless they obtain an approval of the Government Commission on Control over Foreign Investments (FDI Commission).

The relevant provisions of Federal Law No. 114-FZ entered into force on 27 April 2022.

Given that Federal Law No. 114-FZ leads to the discontinuation of the DRs that make up the index universe for the Russian Depositary Indices of the Vienna Stock Exchange (price source: LSE/IOB), the CEE & CIS Emergency Committee has decided the following:

1. The **discontinuation** of all Russian Depositary Indices of the Vienna Stock Exchange (price source: LSE/IOB) effective as of **17 May 2022**:
