General

Elementary File Rules

- Empty lines and lines started with undefined line codes should be ignored.
- Every different type of line has its own format, line order is not important.
- The format of existing fields does not change.
- Fields that are not published remain empty. New fields are added at the end.
- Every line that is not empty starts with line code:
 - code 0001 description of the file type;
 - code 0002 common data of daily price list
 - code 0010 index data;
 - code 0020 symbol daily values;
 - code 0030 block trades data;
 - code 0050 comments;
 - code 0051 field order for line type 0002;
 - code 0052 field order for line type 0010;
 - code 0053 field order for line type 0020;
 - code 0054 field order for line type 0030.

Due to the introduction of a new type of order, there exists a new field value, namely -1. It appears when the best bid/ask are defined by the market order.

**** Possible values:

- A – cross trades;
- B – block trades;
- o – utilized tax allowance;
- S – temporary suspension;
- Z – temporary halt;
- * - 10% daily price limit;
- NP – data not received;
- D – General Shareholders' Meeting will decide on the dividend;

V – payment of interim dividend;

Q – value P/E is calculated on the basis of earnings in the previous year; values without the Q on the basis of earnings two years before)
