Clarification

■ For bonds listed in units of shares the field nominal turnover is always 0. For bonds listed in percentage points the field turnover volume is always 0.

- Compensations (or market prices) are not mentioned for bonds as the prices are created in auctions and every price generated in an auction is indicated as exchange price.
- Due to the discontinuation of the allocation of national security codes (WKN) by Oesterreichische Kontrollbank since April 22nd, 2003, all listings have the default value "000000" (0 = zero) in Field nr. 2.
- Since 1 November 2007, the Unregulated Vienna MTF is considered a Multilateral Trading System (MTF).
