

## SPECIALIST TENDER 2018

### ■ Schedule of the tender procedure for the function as a specialist on the cash market (market segment prime market) of Wiener Börse AG for the period as of 02.05.2018

In the following we want to inform you about the **change in the timing of this year's specialist tender**. Please note that a Specialist Period ends with the beginning of a new period; i.e. all current obligations as Specialist will end by the end of 30.04.2018.

**On Tuesday 3 April 2018, Wiener Börse AG will be starting** the regular annual tender procedure in which all participants are invited to submit bids for the specialist function for shares/ADCs included in the prime market **for the period as of 2 May 2018**.

Eligible to this tender are those trading participants, who are committed as a Specialist and/or Market Maker for shares/ADCs in continuous trading (equity market and/or other securities, continuous trading) at the beginning of this tender.

The tender documents will be sent by Wiener Börse AG via mail to the trading departments of the eligible participants as mentioned above. All submitted bids received within the prescribed period will be opened thereafter at once by Wiener Börse AG and the valid bids submitted by the individual participants will be evaluated and announced for each security separately.
